Foster Care Agreement

Hereby agree to foster “.....” acoloured male/female Cane Corso/Corso X who has come to my attention through the FOCC/BCCS.

I agree to care for “.....” from the date/.../.... Until/.../..... or until a forever home has been found.

1. I further agree to the following foster care conditions:
 1. To accept and consider the dog as a household companion, and to provide him/her with humane care and treatment, including proper food, water, shelter and exercise, and to give him/her a reasonable amount of time to adjust to new surroundings.
 2. To provide emergency medical/veterinary care for which I will be fully reimbursed upon proof of payment.
 3. To safeguard the dog from loss or mishap. This means not allowing the dog to run at large unsupervised, or to be left in a car.
 4. To immediately notify **a member of the BCCS REHOME TEAM** if the dog is lost, and to make every reasonable effort to recover the dog.
 5. **NOT** to give or sell the dog to another person, relative, rescue group, humane association, shelter or pound, or any medical or experimental laboratory or similar organization.
 6. **NOT** to change or alter the dog's appearance in any way, shape or form (e.g., cropping, docking).
 7. To immediately notify the BCCS REHOME TEAM in the event of death during the foster care period.
 8. To allow the BCCS REHOME TEAM to make periodic visits for as often as it deems it necessary.
 9. To immediately notify THE BCCS REHOME TEAM of any change of address or telephone number or of any plans to move during the foster period.
 10. To immediately notify the BCCS REHOME TEAM of any change in circumstance which may prevent me from completing the time period agreed upon under this foster care agreement.
 11. To take advice or instruction from the BCCS REHOME TEAM regarding the feeding and physical needs of “.....” whilst under my care.
 12. Should I decide to permanently adopt the dog, I will notify the BCCS REHOME TEAM and, upon approval, will follow established adoption procedures.
2. I understand that the dog has been checked, and spayed by a veterinarian and that his/her state of health is accurately represented to the best knowledge of the BCCS REHOME TEAM, however no representations are made as to the temperamental or mental disposition of the dog.

The aim of the BCCS is to promote responsible ownership of the Cane Corso and to educate and guide the public as to the correct standard, temperament, health and capabilities of this well rounded and stable breed.

I further promise and agree to indemnify and release the BCCS, its Officers and Directors, of any and all liability arising from any known, unknown, or any unanticipated damages to people or property caused by the dog(s). I am fully aware of, understand, and agree to all the terms and conditions of this RELEASE AND INDEMNIFICATION PROVISION.

 - 4. **I have read and fully understand the terms and conditions of this agreement, and agree that it is not arbitrary and that the provisions herein are common in pet foster care agreements. I further understand that if I fail to comply with any of the terms specified herein, the BCCS has the right to reclaim the dog and to pursue any legal channels to do so.**
